Monthly Update

Fund commentary

The Fund's positive return in May came despite the imposition of a bank levy in the Federal Budget that sparked falls among domestic banks. A positive contribution from technology and gaming stocks assisted the Fund's overall result.

The Fund performed well for investors, providing a positive return in an environment where the overall market fell. The S&P/ASX200 benchmark fell 2.75% as domestic banks, which comprise the biggest portion of the index, fell between 9 and 15%. Over the past three months we have reduced the Fund's exposure to the domestic banks from a peak of 34% to roughly 18% on concerns about their valuations, meaning their negative performance had a smaller negative impact on the fund.

NextDC was the biggest contributor to performance as the stock rose 7% on the back of positive news flow in relation to growth of cloud service operator capital expenditure in

Australia. We used the opportunity to reduce our position in the stock.

Latam Autos was a detractor for performance, with the stock falling 16% in May after a run-up in the prior month. Salva Capital, a family office based out of Melbourne, bought a 5% position in the company during the last week of April.

Donaco contributed to performance, rising 6% after it released a positive quarterly trading update highlighting higher than expected win rates in both their properties.

We sold out of our position in Shriro Holdings during the month.

This works in two ways - the Fund can invest up to 20% of the portfolio in international opportunities identified by the investment team. The Portfolio Manager can also take the market anomalies found globally and use the insights to identify similar opportunities in the Australian market.

Co-investment: Our co-investors receive access to a unique subset of opportunities which they may otherwise find difficult to access. The management team have significant investments in the Fund – they invest for and with you.

Outperformance: The Fund has outperformed the relevant market index by 230% since inception. The Fund is managed from an Australian investor's perspective with consideration for tax and currency outcomes.
