Monthly Update

Fund commentary

Farewell to an old friend – USD bank subordinated debt. A new opportunity in bank hybrids.

Credit markets took a breather in August post the substantial rally over the past six months or so. Whilst we largely view them as noise, there are numerous geopolitical themes prompting investors to sit on the sidelines.

During the month we completed the sell down of our USD Westpac and ANZ bank subordinated debt position. Few investments better highlight the contrarian nature of the Fund than these. Their long term tenor and small coupons saw them aggressively devalued post the GFC, creating an opportunity to invest in two quality banks, where the bond structure was highly sensitive to higher US interest rates and changes to bank capital rules – perfectly aligned with our long term views. This position ultimately generated over a 50% cumulative return for us and our co-investors – one of the best fixed income anomalies we have ever seen.

Despite recent strong credit market performance, we continue to identify new investment opportunities. We rotated some of the above capital into an old ANZ hybrid security which doesn't contain the same unfavourable terms as more recently issued bank hybrids, yet was being priced like one of them. With a yield of Bills + ~300bp (initial ~4.70%) for just two years, we think it stands out.

Investment philosophy
