Monthly Update

Fund commentary

- Thai hotel giant covets NH Hotel's Spanish hospitality.
- Moody's likes what it sees at Tesco.
- Plenty of places to invest new capital both domestically and offshore.

NH Hotel Group performed well as Thai hotel giant, Minor, indicated its intention to acquire the business after purchasing Chinese firm HNA's minority stake.

Moody's placed Tesco on positive outlook for an upgrade back to investment grade. We expect this investment to appreciate further once the upgrade comes through and a considerably larger universe of funds are able to own the name.


We added 1% to our NextDC exposure, investing in its new 4 year deal at 3m Bills +375bp (~5.70% yield), as well as adding to our existing holding in their 3 year bond at a similar yield. NextDC can redeem both of these bonds prior to their maturity, considerably increasing their return.

We also took a 1% position in ANZ's heavily discounted USD floating rate subordinated debt at 3m Bills +~200bp. We originally bought a position in this bond several years ago, divesting it in 2017 at a considerable profit. It recently fell by ~15% on a potential change to UK capital rules which we think are less likely to impact Australian banks, but even if they did, we believe the bonds are now factoring in the change and are happy to re-initiate.

Finally, we added to our holding in UK pub company Enterprise Inns, taking a position in their 7 year senior secured debt at 3m Bills +~400bp (~6% yield).

Investment philosophy

We aim to build long term wealth together with our co-investors by finding and exploiting investment anomalies around the world. Using a focused, patient and considered approach to finding simple investment ideas produces the best environment for creating that long term wealth.

Our experience has shown us that while the market is largely efficient, it can, and regularly does, misprice a small proportion of companies. This mispricing can arise as a result of any number of reasons, but is most often associated with disruptive or cyclical change, new information which is misunderstood by the market as having a permanent impact when it is in fact transitory, or just because they are operating in a sector out of favour with investors.

Our unique process is based on scanning the world for those companies (hence the radar in our logo), discovering the associated valuation anomalies and extracting value from them. We buy good businesses at a good price; businesses that we believe are being valued differently to their long term intrinsic value, but will return to their correct value over time.

Who manages the investment?

Jarod Dawson is the Portfolio Manager and has been managing the portfolio since 2004. Assisted by John Whelan, together they have over 35 years' combined industry experience. Jarod and John are also supported by the broader investment team, with Paul Moore as CIO who has over 30 years' experience in successfully managing investment funds.
