

# Monthly Update

## Fund commentary

- Investors on their toes as Fed rate normalisation remains on track.
- Tattersalls bonds a good bet.
- Lar Espana highlights the critical nature of investing capital offshore.

Investment grade and high yield credit spreads continued to leak wider in March as investors remain watchful given elevated levels of volatility in broader asset markets. As expected the US Federal Reserve increased official interest rates to 1.5% at the low end of their target range during the month, citing stronger labour markets as a key reason for its decision.

We increased our holding in Tattersalls senior unsecured floating rate debt during the month, at a spread of ~1.50% over cash to provide a current yield of ~3.50%. With just over a year to maturity, we view this as one of the cheapest bonds in the

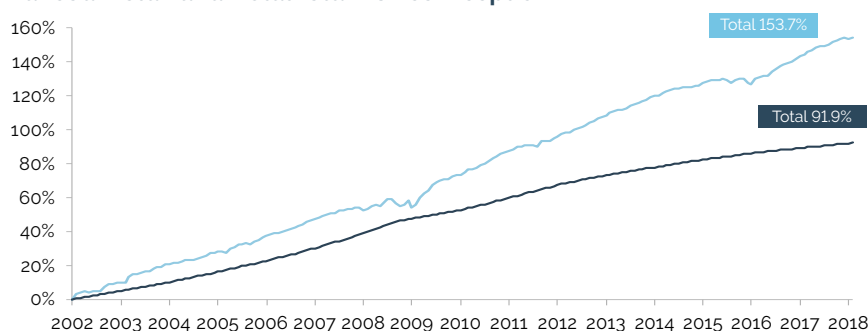
market at this yield.

We sold part of our holding in Lar Espana during the month. This portion of our holding has generated a ~10% p.a. return since we bought our original position several years ago. Lar Espana has been a key part of our investment strategy that recognised early the significant opportunity in European commercial real estate.

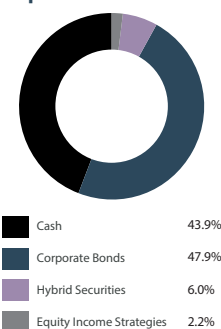
The Fund also purchased some short dated (~1-1.5 year) ANZ and Westpac senior unsecured floating rate bonds in March, at a current yield of ~2.50%. We effectively view these as cash substitutes given their relatively short term to maturity.

#### Investment philosophy

We aim to build long term wealth together with our co-investors by finding and exploiting investment anomalies around the world. Using a focused, patient and considered approach to finding simple investment ideas produces the best environment for creating that long term wealth.

Our experience has shown us that while the market is largely efficient, it can, and regularly does, misprice a small proportion of companies. This mispricing can arise as a result of any number of reasons, but is most often associated with disruptive or cyclical change, new information which is misunderstood by the market as having a permanent impact when it is in fact transitory, or just because they are operating in a sector out of favour with investors.

Our unique process is based on scanning the world for those companies (hence the radar in our logo), discovering the associated valuation anomalies and extracting value from them. We buy good businesses at a good price; businesses that we believe are being valued differently to their long term intrinsic value, but will return to their correct value over time.

Jarod and John are also supported by the broader investment team, with Paul Moore as CIO who has over 30 years' experience in successfully managing investment funds.
